With this purchase, Boustead's shareholding in EasyCall International has increased from 102,876,233 ordinary shares (44.99%) to 103,107,849 ordinary shares or 45.09%.

Mr Wong Fong Fui, Chairman and Managing Director and substantial shareholder of Boustead holds 8,571,500 (3.75%) ordinary shares in EasyCall International. Mr Wong Fong Fui is also an Executive Director and Chief Executive Officer of EasyCall International. After Boustead's purchase of these additional EasyCall International shares, Mr Wong Fong Fui's direct and deemed interest in EasyCall International is 111,679,349 shares or 48.84%.

This transaction is not expected to have any material impact on the consolidated net tangible asset value per share and the earnings per share of the Company for the financial year ending 31 March 2003.

Except as disclosed, none of the Directors and substantial shareholders of Boustead has any interest, direct or indirect, in the transaction.
