# BOUSTEAD SUBSIDIARY AWARDED DESIGN, BUILD AND LEASE CONTRACT FOR PANALPINA FACILITY

### Singapore, 10 August 2007

Boustead Singapore Limited ("Boustead" or the "Company") is pleased to announce that its 91.7%-owned subsidiary, Boustead Projects Pte Ltd ("Boustead Projects") has secured a contract to design, build and lease a new logistics facility (the "Facility") to Panalpina Worldwide Transport ("Panalpina") to be located at Changi North Industrial Park in Singapore.

A groundbreaking ceremony for the Facility was held today and presided over by Mr Volker Sachse, Managing Director of Panalpina South East Asia Region and Mr Wong Fong Fui, Chairman and Group Chief Executive Officer of Boustead, together with key representatives from the Swiss Embassy, Economic Development Board and Jurong Town Corporation.

To be completed by the third quarter of 2008, the Facility will have a gross floor area of approximately 11,270 square metres spread over five floors. The Facility is to be constructed through the expansion of an existing adjacent 23,880 square metre ramp-up multi-tenanted logistics hub (the "Logistics Hub") – owned by Boustead Projects –which is currently fully occupied by reputable multinational logistics companies. Specially-designed to integrate with the Logistics Hub, the Facility will: 1) provide Panalpina with a creative cost-competitive solution; and 2) enhance the value of the existing development.

The Facility's strategic location at Changi North Industrial Park will give Panalpina widespread access across Singapore through the Facility's very close proximity to Singapore Changi Airport and three major expressways: the Pan-Island Expressway, Tampines Expressway and East Coast Parkway.

This is the second design, build and lease contract secured by Boustead Projects in 2007, bringing the total number of industrial leasehold properties (both completed and under construction) in its portfolio to six properties with an expected gross floor area of 86,700 square metres. This contract is also the sixth contract awarded to Boustead Projects since the beginning of the year.

Mr Wong Fong Fui, Chairman and Group Chief Executive Officer of Boustead said, "We are pleased to be given the opportunity to design, build and lease a logistics facility to Panalpina, one of the world's leading logistics companies. We will provide additional value to Panalpina by helping it to achieve an accelerated time-to-market."

"With the completion of the new facility, Panalpina reaches a major milestone in its expansion drive in Singapore and South East Asia in general," said Mr Sachse, Managing Director of Panalpina South East Asia Region. "This further underlines our commitment to Singapore and our confidence in the Singaporean business climate. We thank our

customers for their past and future support, and we are looking forward to the continuous growth of our mutual business."

Mr Sachse added, "Panalpina selected Boustead Projects based on its excellent track record in developing facilities for global logistics companies. We believe that Boustead Projects will deliver facilities customised to meet our requirements in a shortened timeframe, thus allowing us to meet the rapidly increasing demand in Singapore and regionally."

The above contract is not expected to have a material impact on the profitability and earnings per share of the Company in the current financial year ending 31 March 2008. The contract is not expected to have a material impact on the net asset value per share of the Company for the current financial year.
