BOUSTEAD WHOLLY-OWNED SUBSIDIARY AWARDED S\$175M WATER INFRASTRUCTURE SYSTEM IN LIBYA; LARGEST WATER CONTRACT TO DATE

Singapore, 30 June 2008

Boustead Singapore Limited ("Boustead" or the "Company") is pleased to announce that its wholly-owned subsidiary, Salcon Pte Ltd ("Salcon") – a leading global specialist in water and wastewater engineering – has been awarded a S\$175 million-equivalent (152.7 million Libyan Dinahs) EPC turnkey contract to design, construct and upgrade a major water infrastructure system (the "Contract") in Libya. The Contract was secured together with a local joint venture partner, a state-owned utilities company. According to the terms of the joint venture, Salcon will hold a 65% interest in the Contract, which is its largest contract secured to date.

Commencing in July 2008, the Contract comprises two phases to design, construct and upgrade a water and wastewater infrastructure system in Tarhunah, a 731-hectare township located approximately 80 kilometres south east of Libya's capital, Tripoli. The Contract is expected to be completed by the first quarter of 2011.

Under Phase I of the Contract, the joint venture will upgrade Tarhunah's water and wastewater service networks. Phase I is expected to fulfil the water and wastewater requirements of the community until 2015. Phase II consists of the construction of new water and wastewater service networks, pumping stations and additional water treatment plants to meet the future requirements of the community in 2025. The local community will benefit from the Contract through enhanced employment opportunities, skills training and technology transfer offered by Salcon.

The award of the Contract comes shortly after a jointly-organised business mission to Libya in May 2008 by the Singapore Business Federation and International Enterprise Singapore, which Boustead had participated in. Led by Singapore's Senior Minister Goh Chok Tong, the business mission met with key Libyan government ministers and officials, and explored business opportunities in the country.

Mr Wong Fong Fui, Chairman & Group Chief Executive Officer of Boustead said, "We are delighted to have been awarded this milestone contract by the government of Libya. We will continue to explore various opportunities to develop infrastructure – both in water and other areas – in Libya, which we view as a key long-term market."

Mr Michael Teo, Salcon's General Manager for the Middle East and North Africa said, "This is our largest water contract to date. We are looking forward to a very fruitful relationship with our local partner to make this a highly successful water infrastructure system and a good model for other townships to follow."

With a highly positive tone, Mr Wong added, "This is a very exciting build up to our celebrations for Boustead's 180^{th} Anniversary in 2008."

The Contract is expected to have a positive material impact on the profitability and earnings per share of the Company for the financial years ending 31 March 2009, 2010 and 2011. However, the Contract is not expected to have a material impact on the net asset value per share for the current and next two financial years.

None of the Directors or controlling shareholders of the Company has any interest, direct or indirect, in the Contract.
