BOUSTEAD SUBSIDIARY AWARDED S\$18.6M CONTRACT TO DESIGN-AND-BUILD SINGAPORE'S FIRST PRIVATE HOSPITAL FULLY-DEDICATED TO CANCER TREATMENT

Singapore, 2 November 2009

Boustead Singapore Limited ("Boustead") is pleased to announce that its 91.7%-owned subsidiary, Boustead Projects Pte Ltd ("Boustead Projects") – a leading specialist in real estate solutions – has been awarded an S\$18.6 million contract (including GST) to design-and-build the Pacific Cancer Centre (the "Centre"), the first standalone private hospital in Singapore to be fully-dedicated to cancer treatment. The contract was awarded by First Real Estate Investment Trust ("First REIT"), the first real estate investment trust listed on the SGX that specialises in investments in healthcare and healthcare-related assets.

Located along Adam Road, the Centre will be equipped and operated by Pacific Healthcare Holdings Ltd ("Pacific Healthcare"), a specialist healthcare provider with a growing regional presence and which is also listed on the SGX. The Centre will comprise three floors and a basement with a gross floor area of approximately 2,545 square metres. Along with a 24-hour clinic, day surgery facility with operating theatres, chemotherapy suites, consultation rooms, radiotherapy facility, imaging centre, pharmacy and in-patient suites, the Centre will feature high ceilings, lush greenery and open spacious courtyards to provide a conducive environment for treatment and rehabilitation.

The Centre will incorporate state-of-the-art facilities including:

- Advanced cancer screening using PET-CT scan and other diagnostic equipment;
- Multi-disciplinary cancer treatment including chemotherapy, surgical oncology and radio oncology;
- The latest available radiotherapy system;
- 24-hour nursing facilities with extended cancer care services; and
- Five luxurious inpatient suites.

The completion of the Centre is slated for around mid-2011. The Centre forms a strategic part of First REIT's asset enhancement works to enhance the overall value and plot ratio of its portfolio of healthcare and healthcare-related assets.

Mr Thomas Chu, Managing Director of Boustead Projects said, "We are delighted to have been given the opportunity by First REIT and Pacific Healthcare to deliver Singapore's first standalone private hospital that is fully-dedicated to state-of-the-art cancer treatment. The design-and-build of this specialised medical facility, incorporating the latest medical technology, necessitates extra care and planning, and additional engineering processes and technical know-how which we will provide. Pacific Cancer Centre is set to enhance Singapore's standing as a world-class medical hub."

The above contract is not expected to have a material impact on the profitability, earnings per share or net asset value per share of Boustead in the current financial year ending 31 March 2010.

None of the Directors or controlling shareholders of Boustead has any interest, direct or indirect, in the above contract.
