WITHDRAWAL OF PROPOSED APPLICATION OF SCRIP DIVIDEND SCHEME IN FAVOUR OF CASH PAYMENT

The Board of Directors (the "Board") of Boustead Singapore Limited (the "Company") refers to the previous announcement made on 24 May 2016 in relation to the application of the Boustead Scrip Dividend Scheme (the "Scrip Dividend Scheme") to the final tax-exempt (one-tier) dividend of two (2) Singapore cents per ordinary share of the Company for the financial year ended 31 March 2016 (the "Dividend").

The Dividend was approved by shareholders at the Annual General Meeting of the Company held on 28 July 2016. The Share Transfer Books and the Register of Members of the Company closed at 5.00pm on 3 August 2016 for the purpose of determining Shareholders' entitlements to the Dividend.

The Board wishes to announce that having made a re-assessment of the Company's present capital needs and current cash reserves, it is of the view that the Company is sufficiently capitalised for the time being and that shareholders' interests are better served by paying the Dividend in cash instead of scrip.

As a consequence of the decision to withdraw the proposed application of the Scrip Dividend Scheme to the Dividend in favour of cash payment, the Dividend payment date shall be brought forward from 21 September 2016 to 19 August 2016.
