

BOUSTEAD GEOSPATIAL DIVISION AWARDED LANDMARK A\$48M GEOSPATIAL CONTRACT

SINGAPORE, 25 JULY 2023

Boustead Singapore Limited (“Boustead” or the “Group”), a progressive global infrastructure-related engineering and technology group, is pleased to announce that its 88.2%-owned business unit, Esri Australia Pty Ltd (“Esri Australia”) – Australia’s leading geographic information systems (“GIS”) technology and services provider, and exclusive distributor of the world-leading Esri ArcGIS platform – has secured a contract valued at about A\$48 million (approximately S\$42 million) (the “Contract”) with an Australian federal government department. The Contract involves a multi-year Enterprise Agreement that will see Esri Australia provide tens of thousands of Australian government employees with access to state-of-the-art GIS technology. It represents a renewal of an existing arrangement, which includes the provision of the Esri ArcGIS system and after-sales software support services.

Boustead Geospatial Division Managing Director, Brett Bundock said, “While Esri technology has underpinned all levels of government operations in Australia for close to four decades, recent advancements in the platform have fundamentally shifted the degree to which the technology is being leveraged by decision-makers.”

Mr Bundock added, “An unprecedented combination of climate, economic, geopolitical, and global health challenges have brought rise to an appreciation of GIS technology’s enabling capabilities – both as a force multiplier and in the analytics space. This contract demonstrates a clear commitment by the Australian government to prioritise progressive, science-backed approaches to addressing both local and regional challenges.”

Australian governments’ innovative use of the ArcGIS platform was recently recognised at Esri’s Global User Conference, held in San Diego and attended by more than 15,000 delegates from across the world. An Australian federal government agency and state government agency were separately conferred a Special Achievement in GIS (SAG) Award for their enterprising use of GIS technology to develop solutions leveraging integrated geospatial infrastructure frameworks (IGIF).

To varying degrees, GIS solutions facilitate cross-agency, government, private sector and community information sharing and collaboration. This leading-edge approach to unlocking the value held within geospatial data repositories is crucial for enabling government and community groups to prepare for, respond to and recover from large-scale disasters – be they natural or human-made. In addition, the solutions allow for a more informed approach to urban and infrastructure planning and delivery.

Boustead Geospatial Division is ranked among the top exclusive distributors in Esri Inc’s global network, with a user base numbering over 7,000 organisations regionally across the Asia Pacific including Australia, Singapore, Malaysia, Indonesia, Bangladesh, Brunei, Papua New Guinea and Timor-Leste.

The Contract is expected to have a positive material impact on the profitability and earnings per share of the Boustead Group in the current financial year ending 31 March 2024 (“FY2024”) but is not expected to have a material impact on the net tangible asset value per share for FY2024.
