

## **BOUSTEAD REAL ESTATE BUSINESS PARTNERS EVOTION LABS FOR SINGAPORE'S FIRST EV BATTERY SWAP STATIONS; BUILDS UPON GREEN INITIATIVES**

**SINGAPORE, 3 JULY 2024** – SGX Mainboard-listed Boustead Singapore Limited (SGX:F9D) (“Boustead”), a progressive global infrastructure-related engineering and technology group, is pleased to share that Boustead Funds Management Pte Ltd (“BFM”), the principal real estate business unit under the Real Estate Solutions Division, has signed a Memorandum of Understanding (“MOU”) to partner with Evotion Labs Pte Ltd (“Evotion Labs”), a business unit of Mah Pte Ltd, one of the largest motorcycle brand distributors in Singapore.

Under the MOU between BFM and Evotion Labs, the two parties will work together to explore the deployment of motorcycle electric vehicle (“EV”) battery charge and swap stations by Evotion Labs at properties located in Singapore which are managed by BFM and its related entities. With multiple stations across the island, users can quickly swap out depleted motorcycle EV batteries for fully-charged ones in under a minute, eliminating the long wait times associated with traditional charging.

On 31 May 2024, Evotion Labs announced the official launch of Singapore’s first TR25-approved battery charge and swap service in collaboration with NIU (NASDAQ: NIU), a leading global brand in smart urban mobility solutions. Evotion Labs will introduce 22 battery swap stations by the end of 2024, with plans to expand to 400 stations over the next two years. The first two stations are strategically located at Mah Pte Ltd’s headquarters, Mah Building, and Razer Inc’s headquarters, Razer SEA HQ – which is a joint venture property under Boustead’s real estate portfolio. As one of the first two properties to benefit from Evotion Labs’ EV battery swap stations, Razer SEA HQ remains at the forefront of deploying electrification and sustainability solutions that are part of Singapore’s Green Plan 2030.

The partnership with Evotion Labs will further strengthen Boustead’s commitment to greenifying its real estate portfolio and partnering with like-minded renewable and sustainability solutions providers. Boustead’s Real Estate Solutions Division is already the market leader in the engineering and construction of Green Mark Platinum-rated new private sector industrial developments. As a core part of the division, Boustead’s real estate business has continued to deploy rooftop solar energy systems, EV charging stations for vehicles and now, looks forward to the potential integration of EV battery swap stations as well.

Managing Director for Real Estate, Mr Samuel Lim said, “Three years ago, just one of our real estate properties in Singapore had renewable energy or EV solutions. In a short space of time and with our efforts spent to develop partnerships in green solutions, we currently have nine properties that have

rooftop solar energy systems and five properties with EV charging stations. We look forward to working with Evotion Labs to expand on these green initiatives.”

Managing Director of Evotion Labs, Mr John Mah said, “Evotion Labs is proud to partner with BFM to launch Singapore's first TR25 approved battery charge and swap service. This collaboration represents a significant milestone in developing an island-wide network of battery charging stations, advancing our nation's commitment to convenient, eco-friendly and sustainable urban transportation.”

Apart from the eco-sustainable features that have been designed and built into Boustead's developments, Boustead's real estate portfolio under management has nine properties in Singapore with a total solar energy generation capacity of 5.6 megawatt-peak and solar panels covering an area that is the size of over 2.5 soccer fields. These solar panels are able to deliver an estimated 6.3 gigawatt-hours of electricity annually, equivalent to the electricity used to power about 1,420 Singapore 4-room HDB homes annually. Five properties also have a total of 18 EV charging stations for vehicles.

Boustead remains committed to reducing energy and water consumption, along with emissions footprints in its real estate portfolio.
