

BOUSTEAD SCRIP DIVIDEND SCHEME – ALLOTMENT AND ISSUE OF NEW SHARES

SINGAPORE, 26 SEPTEMBER 2025

The Board of Directors (the “Board”) of Boustead Singapore Limited (the “Company”) refers to the previous announcement made on 26 May 2025 and 12 August 2025 in relation to the application of the Boustead Scrip Dividend Scheme (the “Scrip Dividend Scheme”) to the final and special tax-exempt (one-tier) dividends of four (4) Singapore cents per ordinary share (“Share”) and two (2) Singapore cents per Share respectively of the Company for the financial year ended 31 March 2025 (the “Dividends”).

The Board is pleased to announce that 13,103,216 new Shares (“New Shares”) have been allotted and issued at an issue price of S\$1.45 per New Share to eligible Shareholders who have elected to participate in the Scrip Dividend Scheme (“Participating Shareholders”), in respect of the Dividend.

The New Shares (credited as fully paid) were allotted and issued on 24 September 2025 to the Central Depository (Pte) Limited (“CDP”) (for credit to the respective securities accounts of Participating Shareholders maintained with CDP) and to Participating Shareholders who are registered in the Register of Members of the Company. The New Shares will rank pari passu in all respects with the existing Shares of the Company.

Following the issue of the New Shares, the number of issued and paid-up Shares (excluding treasury shares) of the Company has increased from 491,620,580 Shares to 504,723,796 Shares.

The Company has applied to the Singapore Exchange Securities Trading Limited (“SGX-ST”) for the listing and quotation of the New Shares and the New Shares are expected to be listed and quoted on the Official List of the SGX-ST on or around 26 September 2025.

Eligible Shareholders who did not elect to participate in the Scrip Dividend Scheme, Participating Shareholders who had not properly completed and returned the Notices of Election to the Company or CDP, as the case may be, by 5.00 p.m. on 8 September 2025, and overseas Shareholders who did not provide registered addresses in Singapore to the Company, c/o the Share Registrar, Boardroom Corporate & Advisory Services Pte. Ltd., or CDP, as the case may be, will receive their respective entitlements to the Dividends in cash on 26 September 2025.
