

BOUSTEAD JOINT VENTURE TO DEVELOP AEROSPACE FACILITY IN SINGAPORE

SINGAPORE, 22 MAY 2026

Boustead Singapore Limited (“BSL”, and together with its subsidiaries, the “Group”) is pleased to announce a joint venture with UI Boustead REIT for the purposes of investing, developing, owning and operating a build-to-suit aerospace facility (the “Facility”) in Singapore. The joint venture is a Singapore-registered limited liability partnership (the “LLP”). A subsidiary of BSL, Perpetual (Asia) Limited (in its capacity as trustee of UI Boustead REIT), UIB REIT Management Pte. Ltd. (in its capacity as manager of UI Boustead REIT) (the “REIT Manager”) and the LLP have today entered into a Limited Liability Partnership Agreement (“LLPA”). A subsidiary of BSL will hold a 49.0% interest in the LLP, while UI Boustead REIT will hold the remaining 51.0% interest.

The LLP has received a letter of offer issued by JTC Corporation (“JTC”) for a lease of approximately 24.5 years for several lots of land at Seletar Aerospace Road 1 (the “Land”), on which the Facility will be built. The Land has an area of approximately 29,986 square metres.

Boustead Projects E&C Pte. Ltd. (“BPEC”), the principal Engineering & Construction business under the Group, has received a letter of award from the LLP, for the appointment of BPEC to undertake part of the construction work in respect of the Facility. BPEC and the LLP have also entered into an engineering, procurement, construction and management (“EPCM”) agreement, whereby BPEC will be appointed as the EPCM consultant. Under the LLPA, the REIT Manager has been appointed to provide development management services for the development of the Facility.

With the addition of this contract, the total value of new contracts secured by the Group since the start of FY2027 is approximately S\$461 million¹.

In connection with the development of the Facility, the LLP has today also entered into an agreement for lease with a client (the “Client”) – a leading global aerospace corporation – to set out the LLP’s agreement to develop and construct the Facility and to grant a lease of the Facility for the Client (the “Agreement for Lease”).

The above contract is not expected to have a material impact on the profitability, earnings per share and tangible net asset value per share of the Group in the current financial year ending 31 March 2027.

Save for their shareholding (if any) in BSL, none of the Directors or controlling shareholders of BSL has any interest, direct or indirect, in the Agreement for Lease.
